# NCEM Grants Management & Compliance Programs - What Do The Numbers Tell Us?

#### Grants

- NCEM made about 1700 payments across over 20 major recurring federal and state grant programs (disaster & non-disaster) for almost \$485M during state FY21-22 (7/1/21 – 6/30/22).
- Grants Management Branch manages about \$80M - \$85M preparedness grants (non-disaster) per year across the following 10 programs: HSGP, EMPG, NSGP, HMEP, EOC, SLCGP, Tier II, NC 211, VOAD and CBCG.

#### Audits

- Approx. 20 different audits/reviews in 2021 & 2022, some of which are still ongoing, with hundreds of associated documentation requests processed.
- Not a single finding or deficiency for NCEM on any audits completed in 2021 or 2022, incl. comprehensive 2022 FEMA Desk Review with no findings or discrepancies.
- Bottom Line: NCEM managed approx. \$485M in grants in FY21-22 without a single negative audit finding or deficiency to date.





## **NCEM UAS Projects History**

- 2016 HSGP grant award to NCEM Risk Management Section
- 2019 HSGP grant award to NCEM Operations Section
- 2020 HSGP grant award to NCEM/CAP Operations Section
- 2021 HSGP local applicant approved pending waiver





## **UAS Projects with NCEM Preparedness Grants**

- 1st Eligibility as a state entity or part of the domestic preparedness regions
- 2<sup>nd</sup> Ensure your agency can meet the eligibility criteria for the waiver approval
- 3rd Ensure the project proposal description is robust with budget breakdown
- 4<sup>th</sup> Schedule steps following NCEM approvals to include waiver processing
- 5<sup>th</sup> Continue work through Period of Performance with Grant Manager





## **HSGP UAS/sUAS Requirements**

- Authorized Equipment List (<u>AEL</u>)
  - <u>030E-07-SUAS</u> System, Small Unmanned Aircraft
- HSGP UAS/sUAS Request Checklist FEMA's Grant Programs Directorate (GPD) developed this checklist to serve as a tool to assist stakeholders in their preparation of UAS/sUAS requests.
  - Recipient Support Letter
  - Request Justification
  - Request Certifications
  - Policy Requirements





#### **Procurement Under Federal Grants**

- Federal Purchasing Thresholds
  - Micro-Purchase Threshold (MPT): up to \$10K (no competition required)
  - <u>Simplified Acquisition Threshold (SAT):</u> up to \$250K (typically 3 quotes + required price/cost analysis)
  - Full Competitive Bidding: over \$250K
  - Sole-Source Justification: no competition required if sole source properly justified
- <u>Procurement with Federal Grant Funds State Entities</u> follow state procurement policy (plus certain required fed. contract clauses)
- <u>Procurement with Federal Grant Funds Non-State Entities</u> follow strictest of federal, state and local procurement policy (plus certain required fed. contract clauses)
- Purchasing under FEMA Grant Award Common Mistakes to Avoid sole source not justified, missing or incomplete procurement documentation, missing required price/cost analysis for SAT, etc.)
